- You are a qualified participant in the Music Contest because you are a Louisiana high school junior or senior attending a Louisiana public or private high school, home school or GED program.
- You understand that if you are a senior you must be enrolled in college for the Fall 2020 semester in order to be eligible to receive the award of a college scholarship.
- The music being submitted is an original work created solely by you.
- The music being submitted does not infringe or violate any third party copyrights, trademarks, or other intellectual property rights.
- The music being submitted meets the requirements listed below.
- You have read these terms and conditions and you understand and agree to them.
- You may submit only one music entry per student. Additional music entries will be deleted and disqualified. Violation of any of these warrants will disqualify your submission.

The Foundations will evaluate submissions using the following guidelines:

- Judging for the art contest will be a blind, objective online process and entries will be judged on a point system based on three categories:
 - 1. Structure and Composition (1/3 of score)
 - 2. Rhythm (1/3 of score)
 - 3. Lyrics (1/3 of score)
- Entries not submitted by the deadline or in a form that is required by this contest will not be considered.

AWARDS

First Place - \$5,000 college scholarship

Second Place - \$3,000 college scholarship

Third Place - \$ 2,000 college scholarship

*The three finalists will have a chance to record their winning songs in a state-of-the-art professional recording studio under the mentorship of Grammy-winning producers and engineers, and then perform their song on stage during the Trombone Shorty Foundation's annual "Shorty Fest" benefit concert during the New Orleans Jazz & Heritage Festival.
